## 1.0 Introduction

As part of efforts to strengthen organizational capacity to support quality improvement, all Family Health Teams are required to complete and submit this attestation annually. The purpose of this document is to demonstrate sound governance practices and compliance with terms of the FHT funding agreement with Ontario Health.
